

# BEAUFORT COUNTY PALS

## 2018 ADULT SOFTBALL RULES AND REGULATIONS

1. General. This league is sponsored by Beaufort County Parks and Leisure Services and shall be governed by the following rules and regulations as adopted by team representatives. Contact for Adult Softball will be Darrell Ketola (843-255-6714 or [dketola@bcgov.net](mailto:dketola@bcgov.net)).

- League Committee. The following people shall serve to draft, interpret and enforce the rules and regulations of this league:
  - 1) Shannon Loper
  - 2) Mark Rennix
  - 3) Matt Watts
- Protests. All protests must be filed, in writing, within 24 hours after the completion of the protested game. Additionally, a \$25.00 filing fee must be made at the time the protest is filed and made payable to Friends of Youth Athletics in Beaufort County. Umpire judgment calls are not to be protested. The committee will rule on all protests within 48 hours of the filing. All decisions made by the committee are final. In the event a protest is upheld, the filing fee shall be returned. If the protest is not upheld, the filing fee shall be used for the purchase of equipment for PALS' athletic fields.
- Insurance. Beaufort County Parks and Leisure Services does not provide any insurance for its adult participants. Teams and team members play at their own risk.
- Team Registration Fees. The cost for participating in this league will be \$450. This fee goes towards paying for an umpire, balls, chalk, and field maintenance. All team registration fees are due on specified date. There are no exceptions!
- Alcohol. Absolutely no alcoholic beverages or drugs are allowed on Beaufort County Parks and Leisure Services facilities. Consequences for violations are:
  - 1<sup>st</sup> Offense: The team will be suspended until a \$100 fine is paid to Beaufort County. The manager is responsible for the entire team.
  - 2<sup>nd</sup> Offense: The team will be suspended until a \$100 fine is paid to Beaufort County. The team will also forfeit game(s) played on that date.
  - 3<sup>rd</sup> Offense: The team will pay a \$100 fine to Beaufort County. Team will forfeit the remainder of the season, along with the entire team roster will be suspended for 1 year.
    - Notes: For players / coaches to be under the influence of alcohol and or drugs while playing softball is prohibited. The umpire or the PALS staff member in charge will eject any player(s) if they suspect alcohol or drugs have been used.
- Tobacco. Tobacco products (cigarettes, cigars, chewing tobacco, snuff, dip or any other tobacco or tobacco derived substance) are not permitted on Beaufort County property (includes on the field, outside the fenced areas, in the parking lot, etc.).

### 2. Eligibility.

- Rosters. A maximum roster size of 22 players (including managers and coaches). **Rosters are locked in the day before your games (Ex. If your game is on Tuesday, your roster is set as of Monday – no player will be eligible if they register the same day as their game). No changes or add ons to rosters can be made at the field. NO CHANGES CAN BE MADE TO ROSTERS AFTER FRIDAY, MAY 4<sup>TH</sup>.** Only those listed on the rosters are permitted on the field or in the dugout. All players must have a picture ID accessible at all times. If a player is on the field and he/she can't produce a picture ID they will be removed from the game. If the player is found to be ineligible the game will be a forfeit. Team reps can call Darrell for an up to date team roster.
- Multi-League Participation. All men's league players are also eligible to participate in the Co-ed league. Players can move up or down one division. Two (2) player max per team (Ex. A team in the Silver League can only have two (2) players on their roster that are also participating in the Gold League). Explanation of who can move where below:

- Gold League – Players in the Gold League may also play in the Silver League.
- Silver League – Players in the Silver League may also play in the Gold or Bronze Leagues.
- Bronze League – Players in the Bronze League may also play in the Silver League.

\*\*\*Any team in violation will be subject to the consequences under Ineligible Player\*\*\*

- Waivers. Each player would need to register on [www.bcpals.com](http://www.bcpals.com). Players may also register at either recreation centers – Buckwalter Recreation Center or Burton Wells Recreation Center.
- Uniforms. All players are required to play in a numbered uniform, jersey, or similar colored T-shirt (no similar colored t-shirts will be allowed after Friday, May 4, 2018). Your team must have the entire uniform by Friday, May 4, 2018.
- Switching Teams. A player may switch teams only with the consent of both team's coaches and the approval of PALS. The change must be reported to PALS prior to the next scheduled game. After Friday, April 27, 2018, there will be no changes. Players may not move from one league to another (i.e. - Gold to Bronze) after the 1<sup>st</sup> scheduled game.
- Tournament Eligibility. All players on the roster are eligible for the tournament.
- Ineligible Players. Consequences for violations are:
  - 1<sup>st</sup> Offense: Forfeit of all game(s) ineligible player participated in.
  - 2<sup>nd</sup> Offense: Team is ineligible for the tournament.
  - 3<sup>rd</sup> Offense: Team will forfeit the remainder of the season, and the entire team roster will be suspended for 1 year.

### 3. Unsportsmanlike Conduct.

- General. Unsportsmanlike conduct, either on the field or within the confines of the field, will not be tolerated. This applies to teams, individual players, coaches and spectators. Violators are subject to appropriate action by the league committee and / or PALS, including suspension or expulsion from the team or the ball park.
- Suspensions and Fines. Any coach or player ejected from a game by an umpire will be suspended for one game and pay a \$25.00 fine to Beaufort County before being reinstated. Each ejection thereafter will increase the fine, for that individual, by \$25. (example – 1<sup>st</sup> ejection = \$25, 2<sup>nd</sup> = \$50, 3<sup>rd</sup> = \$75 and so on...) This includes tournament games. This money will be used to finance youth sports scholarships. Number of ejections will also be the first tie breaker for playoffs/seeding – the team with the least amount of ejections (hopefully NONE!) will win any tie breaker scenarios.
- “Flagrant” Misconduct. If, in the sole discretion of the umpire, such an ejection is due to flagrant misconduct or unsportsmanlike conduct, then the following penalty will be imposed: a fine of \$25.00 payable to Beaufort County will be levied and a five game suspension will be imposed. Additionally, the offending individual may be subject to banishment from the league. The League Commissioner will rule on this decision, and all decisions are final. “Flagrant” misconduct or unsportsmanlike behavior shall include but not be limited to the following:
  - Intentionally trying to cause injury to another player.
  - Pushing or striking a league official.
  - Excessive verbal abuse of an umpire or league official.
  - Fighting or striking an opposing player or coach.
- Ejections and Multi-League Play. If a player is ejected from any game and plays on both leagues, that player must sit out the suspension time and then pay the \$25.00 re-instatement fine payable Beaufort County before that player can play in ANY League game.
- Notification Responsibilities. In the event of an ejection, the umpire shall notify the PALS representative / office of the number, name, and team of the ejected individual(s). In the event the ejection was for “flagrant” misconduct, the umpire shall notify the league committee within 24 hours by a written report of the incident.

- Illegal Bats. Any player/team found to be using an illegal bat will be an immediate forfeit and fined \$50.00. That player/team must pay the \$50.00 fine to Beaufort County before that player/team can play in any League game.

#### 4. Player Minimum.

- A coed team must consist of ten (10) players **of which at least four (4) are female**. A coed team consisting of 12 players *batting* will include five (5) females. A team may finish the game with 3, 2, or 1 female(s) only in the event of injury. **Girls may play anywhere**. A coed team can start a game with three (3) female players, but can only play nine (9) players until/unless a fourth female arrives.
- An all male team participating in the Coed League will consist of players that are of a minimum age of 55 years and they may bat 11 players.
- Men's league teams will consist of ten (10) players with the option to use an "extra hitter" and bat eleven (11) players or bat a DH which the team would bat 10.
- A team must have a minimum of nine (9) players to start a game. **If a team does not have 9 players they may borrow a player from the opposing team only.** (This is not mandatory, but is simply an option to help teams avoid forfeits and the opposing coach will choose the player that is borrowed). The tenth spot in the line-up is no longer an automatic out if a team can only field 9 players. If the tenth player arrives at any time during the game, they will enter the line-up at the 10<sup>th</sup> spot in the batting order immediately upon arrival.
- If a team begins play with nine (9), ten (10), or eleven (11) players, that team may continue the game with one less player than it began with whenever a player leaves the game for any reason other than an ejection. If the loss of a player is the result of an ejection and that team does not have enough personnel to match its original starting strength, then the game shall be a forfeit in favor of the opposing team. If the player leaving the game is a base runner, he shall be declared an out.

#### 5. Game Time.

- The first game time will be 6:30 pm.
- The first game is the only game with a ten-minute grace period.
- Games will be no longer than one hour in length. Game length is seven (7) innings. Tied games will continue until the tie is broken and a winner can be determined.
- All games are official after four (4) complete innings of play. Any game rained out before the fourth inning is complete will be rescheduled and played from the time of cancellation.
- Should the first scheduled game at 6:30 pm be declared a forfeit due to the inability of one team to field enough players, there is no grace period for this second game or third game.
- Tie-Breaker Rule. If two teams are tied at the end of the regular season, the team with fewer ejections will be the winner. If the two teams have the same amount of ejections, the team with the better head-to-head record will be declared the winner. If the two teams split their head-to-head regular season match-ups, the run differential between the two teams will determine the winner. If the run differential is a tie, then the two teams will have a one (1) game playoff to determine the winner.

#### 6. Line-ups.

- Managers / coaches must give the other team their roster / batting order no later than ten (10) minutes before game time for each game.
- Managers / coaches must notify opposing team of all line-up changes or substitutions as they occur.

#### 7. Equipment.

- Only ASA approved equipment will be permitted. All bats used in league play must have the official ASA "Certified" logo on them. All coaches are responsible for checking each team's bats. They must have original grip. If they are in question of a bat they need to consult the umpire BEFORE the game begins.

- Only softballs issued by the PALS representative before the games shall be used. **Balls should be collected between innings and after games. 2 balls will be given per game.**
- No metal cleats, street shoes, or bare feet shall be allowed. Only rubber cleats or tennis shoes shall be worn in games.
- L-Screens may be used by the pitcher. If at any time a batted ball hits the L-Screen, it is considered a foul ball. (The same rules for “courtesy foul balls” will apply to balls that hit the L-Screen)

8. Home Run Rule. There is a maximum of five (5) homeruns per team per game on all fields. Every homerun after the fifth homerun for that team for that game will result in an automatic out. In the event of a homerun all players may walk to the dugout. No base running is required by the batter or any player already on base.

9. Mercy Rule. The mercy rule is in effect during regular season play and tournament play except for the championship game. When any of the margins listed below are reached, the game will end in favor of the team enjoying the margin.

- After three innings of play: margin of 20 or more runs.
- After four innings of play: margin of 15 or more runs.
- After five or more innings of play: margin of 10 or more runs.

10. Courtesy Runners. Each team is allowed one courtesy runner per inning.

- Courtesy runners may be used at any time. Courtesy runners must be of the same sex as the base runner they are replacing: male for a male; female for a female.
- Any player may be used as a courtesy runner. In the men’s league you may only have one courtesy runner per inning. In the co-ed league you may have two courtesy runners per inning. However, you are only allowed one of each sex and it must be a male for a male and female for a female.

11. CO-ED Rules. When a female is batting only 6 players may stand in front of the orange outfield line. When the ball is hit:

4 outfielders behind the orange:

A. Can catch the ball behind the orange Line in the air

B. Cannot force a player out at any base.

12. Officials. One umpire per game will be used during the regular season, and two umpires per game for tournament play.

13. Make-up Games.

- All games officially postponed due to weather or other reasons shall be rescheduled by the League Commissioner.
- Games may not be rescheduled or postponed except by prior approval from the PALS department. A minimum of one week’s notice is required for rescheduling consideration.
- PALS reserves the right to cancel make-up games which would have no impact on the final standings and / or tournament seeding.

14. Forfeits.

- Any team that forfeits four (4) games shall be automatically suspended from the league for the remainder of the season and tournament play. Forfeits will be declared in their spot. There will be no refund of registration fees.
- Forfeits shall be scored 7-0 in favor of the non-forfeiting team.

15. Litter. Each team is responsible for picking up trash in and around their respective dugout. Please don’t litter!

16. Tournament Play. The following rules shall apply to Tournament play.

- Tournament seeds are determined by the regular season standings.
- There will be no time limit in any playoff game including the championship game.
- During the Championship Game there will be no mercy rule in effect.
- The team with the better regular season record / higher tournament seed will have the option to choose being the home or visitor team in the "Winners' Bracket" throughout the tournament. In the "Losers Bracket," the home team option will be determined by a coin flip.
- There will be a ten (10) minute break before the championship game.
- PALS will determine the number of teams for playoffs dependent upon the number of teams in the league.
