

#### ARTICLE I – RECREATION CENTER RULES

- 1. A valid membership pass is required to use our recreation facilities. Daily passes may be purchased by Beaufort County residents (tax payer status determines fee), and out of county or state residents. Weekly, monthly, or yearly passes may only be purchased by Beaufort County tax payers. Proof must be provided. Participants must check in at the front desk to gain entry into the facility. Using another participant's pass to gain access is prohibited. Students that attend Beaufort County Public schools are free. Must bring a school ID, report card, schedule, or note from the school attending. Any student attending a private school must show proof as a Beaufort County tax payer, or live with a parent who is.
- 2. Youth under the age of 12 must be accompanied by an adult. Youth may not enter the center until 3:00pm when schools are in session (this excludes home school students).
- 3. Daily entrance to our recreation centers are limited to twice daily. Once a participant leaves the recreation center, that participant must wait a minimum of 3 hours before they are allowed to re-enter. All other doors are not to be opened under any circumstances unless an emergency arises.
- 4. All clothing attire must be worn appropriately. Shirts and shoes must be worn at all times. Pants must be worn around waist. Only athletic shoes are allowed.
- Only clear bags are allowed into the facility. Any participant caught bringing in a bag that is prohibited will be suspended from the facility for an indefinite period of time.
- 6. Beaufort County Parks and Recreation are not responsible for any lost or stolen items brought into our facilities.
- 7. Food, gum, and drinks are not allowed. Water in a closable bottle may be brought into the facility.
- 8. Alcoholic beverages, smoking, and tobacco (*e-cigarettes/Vapor*) products are not allowed on Beaufort County property.
- 9. No running or horseplay in the hallways or corridor. No bouncing balls outside of the gym. Do not bounce balls off of walls or place feet on walls.



- 10. No personal basketballs or volleyballs are allowed in the facility. Balls may be checked out at the front counter, but must be returned upon departure. Balls are not to be left with anyone else. If a ball is not returned, your account will be charged the replacement fee.
- 11. Profanity or vulgar language is not allowed. Consequences are as follows:
  - 1<sup>st</sup> offense Warning
  - 2<sup>nd</sup> offense Suspension from the facility for 1 week
  - 3<sup>rd</sup> offense Suspension from the facility for 1 month
  - Any offense after the above could result in permanent suspension from the facility
- 12. No pets or wheels are allowed into the facility. Only strollers and wheelchairs are allowed.
- 13. Beaufort County Parks and Recreation staff reserves the right to remove any person from the property for violation of the recreation center policies.
- 14. Violations can also result in your membership being suspended or terminated.
- 15. Fees and policies are subject to change.

#### **ARTICLE II – GYMS**

- 1. Dunking and/or hanging on the rims are prohibited. Consequences will be as follows:
  - 1<sup>st</sup> offense Warning
  - 2<sup>nd</sup> offense Suspension from the facility for 1 week
  - 3<sup>rd</sup> offense Suspension from the facility for 1 month
  - Any offense after the above could result in permanent suspension from the facility



2. Organized practices and trainings are prohibited unless they are affiliated with a Beaufort County Parks and Recreation program, or scheduled through Beaufort County Parks and Recreation.

## <u>ARTICLE III – WEIGHT ROOM/CARDIO EQUIPMENT</u>

- 1. Participants 14-17 years of age must be accompanied by an adult. Anyone under the age of 13 is not allowed in the weight room or on the cardio equipment.
- 2. All weights must be returned to the racks when finished being used. Do not take any equipment out of the weight room. Do not drop weights on the floor.
- 3. Wipe off the equipment with a towel after each use. Towels are not for personal use.

## <u>ARTICLE IV – TRACK (BUCKWALTER)</u>

- 1. Youth ages 16 and younger must be accompanied by an adult and must stay within arm's length.
- 2. All users must travel in the same direction as indicated. The inside lane is for walking; the outside lane is used for jogging and passing.
- 3. No standing or laying on the track.
- 4. Strollers are allowed on the track, but wheels must be cleaned before entry and in good condition.
- 5. Do not lean on the rails, place objects on the rails or ledges of the track. Anyone throwing objects from the track will be subject to removal and/or suspended from the facility and subject to prosecution by local law enforcement.

#### <u>ARTICLE V – RACQUETBALL COURTS</u>

- 1. Racquetball courts are first come, first served.
- 2. To reserve the racquetball courts, you must contact our main office for Burton Wells at 843-255-6680 and for Buckwalter at 843-255-6710.



- 3. Protective gear must be worn at all times (goggles).
- 4. Shoes with black soles are NOT allowed (this includes athletic shoes).

### ARTICLE VI – BATTING CAGES (BUCKWALTER)

- 1. Youth 12 years of age and younger must be accompanied by an adult.
- 2. To reserve the batting cages, you must contact our main office for Buckwalter at 843-255-6710.
- 3. A batting helmet must be worn when participants are hitting.
- 4. Bats and helmets are provided. Personal batting equipment are allowed, but Beaufort County Parks and Recreation is not liable for any damaged or stolen equipment.
- 5. Once entering the batting cages, user is not permitted past the mat or line.

I have read and understand these policies. I fully understand the terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement. I also understand Parks and Recreation reserves the right to remove anyone from the facility at any time. Parks and Recreation also reserves the right to close the facility at any time and for long periods of time for Parks and Recreation programs or events.
